Payment of Fees: Invoices will be issued 30 days prior to the due date and must be paid by the due date.

Pay-in-full Discount: A 5% fee discount is available for families who pay their fees in full prior to or at the Annual General Meeting (AGM). This discount applies only to the term fees and not to other charges (i.e. does not apply to the Enrolment Deposit, Incursions/Excursions Levy or Participation Levy). Payment plans are available if required.

Enrolment Deposit: This payment secures a child's place at the service and is payable on offer of enrolment. The deposit is retained and then deducted as part payment on term fees and other charges in Term 1. Families experiencing hardship should discuss any difficulties with the service.

Participation Levy Refund: The Participation Levy will be refunded to parents/guardians who are involved with specified activities, which may include working bees, kinder open days, committee positions, fundraising events, etc. Involvement in one such specified activity will result in a \$25 credit, while involvement in two or more activities will result in a maximum credit of \$50, paid at the completion of the kinder year.

Kindergarten Fee Subsidy: Families who are eligible for the Kindergarten Fee Subsidy (refer to Fee information for families) will not be required to make fee payments in 2020. This will be reviewed on an annual basis as the gap between the fee subsidy and fees charged is subject to fluctuation. Families are still required to pay other charges, which include the Enrolment Deposit, Participation Levy and Incursions/Excursions Levy.

Late Collection Charge: The Committee of Management reserves the right to implement a late collection charge when parents/guardians are frequently late in collecting a child (refer to Fee Information for Families).
